Surrogate Parent Training

April 21, 2022: 8:30 AM – 11:30 AM

This course provides prospective surrogate parents an understanding of their role in representing students with disabilities and their educational interests. Surrogate parents will learn the requirements of the Individuals with Disabilities Act (IDEA) and the Georgia state rules and regulations as they relate to the referral, placement, and IEP process. Participants will receive information on statewide and community agencies to contact for further assistance in their role as a surrogate.

Audience: Individuals as referred by GRESA systems and schools.

Participants cannot be employed by the system or agency in which they wish to serve as a surrogate parent.

Training Objectives for Surrogate Parents

1. Surrogate parents will have an understanding of:
 - Their role in representing students with disabilities being considered for special education assessment and/or placement
 - Requirements for serving as a surrogate parent
 - Liability considerations when serving as a surrogate parent
2. Surrogate parents will become familiar with selected requirements of the Individuals with Disabilities Act (IDEA), P.L. 101-476, including:

- The provision of a free, appropriate public education (FAPE) to each student with a disability
 - Education of all students with disabilities in the least restrictive environment (LRE) to the maximum extent appropriate
 - The development of an Individualized Education Program (IEP) for each student with a disability including each IEP component required by IDEA (P.L. 101-476)
 - Procedural safeguards for parents and students with disabilities, including, but not limited to, due process procedures, protection in evaluation procedures, and confidentiality
3. Surrogate parents will receive information on statewide and community resources/agencies to contact, should they need further information
